- 7. **Skill Test** will be conducted for the posts of **Personal Assistant, Stenographer and UDC only.** Shortlisted candidates, who are found to fulfill the eligibility criteria of related post after document verification, will be called for Skill Test. **Skill Test will be qualifying in nature** and final selection will be made purely on the basis of marks obtained in the CBT.
- 8. **No Skill Test is proposed for the remaining posts**. Only those candidates, who are found to fulfill the prescribed eligibility criteria of the post **after document verification** will be considered for final selection. Final selection will be made on the basis of marks obtained in the CBT.
