Advertisement for filling up of one post of Lower division Clerk (1-UR) under UR category on Direct recruitment was issued vide notification number: F No/AIIMS/MG/Admin/Recruitment/03/2019-20/NonTeaching/01, dated 03-05-2019, along with other posts.

The CBT for the post of Lower Division Clerk (Group C) alongwith Nursing Officers Gr II, Warden Male, Stenographer, MSSO Gr.I was conducted on 21-09-2019 and a qualified provisional eligible list for all the given posts was published on 05-10-2019.

It was intended to call the candidates at the ratio of 1:15, but sixteen(16) provisionally qualified eligible candidates were called due to bunching of marks in CBT, for the skill test held on 27-12-2019 at Vijayawada.

- The Cut-Off in CBT for the post of LDC is 71%.
- The successful candidate shall be issued offer of appointment in due course.
- Further, the candidate should note that his candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Mangalagiri, if at any stage of his appointment is found that he does not fulfil any eligibility



criteria or conditions or if he has concealed or given incorrect information which if known earlier, would have rendered him ineligible for selection to the post of LDC.
