EOIs are invited from all eligible bidders from the Telecom Infrastructure Provider (IP) for the following work at AIIMS Mangalagiri. The EOI notice will be available on [www.aiismangalagiri.edu.in](http://www.aiismangalagiri.edu.in) under EOI/Quotations.

The pre-bid Tender meeting will be held on **14/10/2021 03:00PM** Virtually (ZOOM). Joining link for Pre – Bid meeting will be made available on [www.aiismangalagiri.edu.in](http://www.aiismangalagiri.edu.in) website under EOI/Quotations section. The agency(s) may get clarified any confusion regarding any terms and condition of the contract during pre-bid meeting and thereafter any claim of doubt/confusion or any things relating to this contract will not be entertained and it will be deemed that the agency has understood everything about this tender. Based on queries of the bidders, committee members will decide to issue any amendments/corrigendum for the tender

**Sealing and marking of bids:**

1. All interested vendors are requested to send their bid for work of the above item as per details technical specification given and Price Bid. Hard copies in spiral binding of all the documents of technical bid are to be submitted physically in one sealed envelope addressed to the O/o AO (Procurement), 4th Floor, Nursing College building, AIIMS Mangalagiri, Guntur-522503. The bidder's name, telephone number and complete mailing address should be indicated on the cover of the outer envelope. It should reach before the date of opening of the technical bids. The envelope should be clearly marked "*Technical bid for Installation and Erection of Telecom Tower Sites inside the AIIMS Mangalagiri Campus*" and second envelope "*Price Bid*". Both envelopes should be sealed. The Important information related to EOI are as follows
2. If the envelope is not sealed and marked as required, the Contractee will assume no responsibility for the bid's misplacement or premature opening.
3. The Bid document submitted should be Serially numbered and contain the table of contents with page numbers.

**Deadline for submission of bids:**

1. Bids must be received by the Contractee at the address specified not later than the time and date specified in the notice invitation for Bids.

**Modifications and withdrawal of bids:**

1. The Bidder may modify or withdraw its bid after the bid's submission, provided that written notice of the modification or withdrawal is received by the Contractee prior to the deadline prescribed for submission of bids.
2. The Bidder's modification or withdrawal notice shall be prepared, marked and dispatched in a sealed envelope. A withdrawal notice should be through a signed confirmation by the bidder. The Contractee should receive it before the deadline for submission of bids

## INSTRUCTIONS TO BIDDERS FOR SUBMISSION OF BID

1. It is the responsibility of the bidder to ensure that their bids whether sent by post or by courier or dropped by person in the Tender Box should reach within the stipulated date and time.
2. You are requested to quote your rate of rent in the attached format for price bid (Part-VI) in a separate sealed envelope.
3. You may send your representative in the office of the undersigned at the scheduled date and time of opening of EOI.
4. Offer should be submitted under TWO-BID system in two separate sealed covers i.e. “Techno- commercial bid” and “Price Bid”.
5. The bids under Two-Bid System will consist of two parts as per following details: -
  - a. **Technical bid (Part 1)** consisting of all technical details along with Commercial terms.
  - b. **Price bid (Part 2)** indicating price as mentioned in commercial bid (Part VI).
6. In stage-one, only the Technical (Part 1) shall be opened and evaluated. In stage-two, the Price bids (Part 2) of only the technically qualified and acceptable offers will be opened, for further evaluation.
7. If the opening day falls on any holiday, the date of any of the events mentioned above shall be on the next working day.
8. Validity Period: - The validity period of the EOI should be clearly specified. It must be at least for 180 days from the opening of the price bid.
9. Conditional offer will not be accepted.
10. This EOI is divided into six Parts:
  - a) Part I— General Conditions
  - b) Part II— Technical Terms and Conditions
  - c) Part III — Standard Condition of EOI
  - d) Part IV — Special Conditions of EOI
  - e) Part V — Evaluation Criteria
  - f) Part VI—Price Bid
11. Placement of License: The License / MOU will be placed against the Telecom Infrastructure Provider who will quote the highest leased rate in commercial bid.
12. This EOI is being issued with no financial commitment and the Licensor reserves the right to change or vary any part thereof at any stage. Licensor also reserves the right to withdraw the EOI, should it become necessary at any stage to withdraw the EOI.

## **PART -I : GENERAL CONDITIONS**

1. The telecom solutions such as roof top tower or other places (hill top) based on current and future requirement of network coverage to be installed at different parts of the Campus. This is to be decided based on a proper survey of the campus.
2. The telecom infrastructure provider shall be bound to share the infrastructure with multiple telecom operators (minimum 03) on non-discriminatory basis.
3. IP will bear the cost of Electrical connections incurred to the Institute as per prescribed rate of AIIMS Mangalagiri. Institute will provide Electric Connection with Standby Power. The provider has to provide UPS to the site as per the load/need.
4. IP must pay a monthly rent to AIIMS Mangalagiri for the telecom solution to be installed at AIIMS Mangalagiri owned building and land/hilltop.
5. Any installation of telecom solution in the area of AIIMS Mangalagiri must have an attestation well in advance from the competent authority of AIIMS Mangalagiri.
6. IP will take the responsibility of any accidental incident such as technical/ equipment based/ security standards. AIIMS Mangalagiri will not be responsible for any such incidents.
7. AIIMS Mangalagiri shall provide all support in implementation and coordination and shall help in getting the necessary approval for the fulfilment of proposal.
8. IP should meet all the eligibility criteria as per the DoT guidelines and should have all the required compliance certificate/approval in place to provide shareable (mandatory) telecom solution such as ground based mast/roof top tower/ IBS (In Building solution) and Wi-Fi to support data services & 2G, 3G, 4G, 5G or any other future ready network/technology.
9. For adding every new telecom service provider, the Telecom Infrastructure Provider/IP must take written consent of AIIMS Mangalagiri.
10. The tenure of the agreement is for 05 years that can be renewed for next 05 years based on the satisfactory performance of this contract and need of the Institute.
11. Last mile of each network will always be in Fibre.
12. The IP should adhere to all the rules and regulations of Govt. of India published from time to time.
13. The IP needs to create dedicated Wi-Fi hotspots for AIIMS Mangalagiri as per the need of the Institute.
14. IP should deploy standard telecom poles to be shared by multiple operators.
15. During installation and subsequent maintenance, IP should keep intact the existing infrastructure of the campus.
16. The IP should obtain all approvals, permits etc. from all concerned at their own cost and discharge all obligations thereof.

17. The Institute may use the route of the OFC within the campus for its own requirements. No approval or intimation is required from the IP. All the route plan/network diagram has to be shared with AIIMS.
18. Cumulative radiation from the cell tower should be within the approved frequency range of Govt. of India and its dealing organizations. The IP will have to obtain the necessary audit/certification, from the concerned authority as per GoI norms.
19. Mobile signals must be available 24×7×365days inside all buildings of the campus, IP must test the radiation levels of the installed equipment every six months and a detailed report should be submitted to AIIMS Mangalagiri.
20. During execution any underground optical fiber cable / other cables must be laid through HDD (Horizontal Directional Drilling) machines only. Open excavation along roads is not accepted
21. All wires / cables should be concealed and not visible to outside, open cabling is not accepted.
22. Penalty of Rs.10,000/month will be imposed in case of less than three operators.
23. Penalties/Fines for improper service may be levied by the competent authority of AIIMS Mangalagiri.
24. Bidder has to furnish experience in the field of providing IBS services to government institutions.
  - a) Average turnover of company should be Rs50 Cr in last 5 years
  - b) Experience of
    - i. Installing IBS in AIIMS or INI Medical institutes

OR

  - ii. Providing IBS in 5 government hospitals
25. Suitable exemption will be provided to MSME as per Government of India directives regarding experience and turnover.

1. Site Survey, the detailed survey report along with the proposal is required to be submitted by the bidder along with technical bid for technical evaluation.
2. During Technical Evaluation the decision of the competent authority at AIIMS Mangalagiri on compliance with regard to technical specification shall be final. This reserves the right of rejecting any offer. Incomplete offers may be rejected.
3. Requirement of Installation/commissioning- Installation and commissioning should be completed within six weeks from placement of license. Any delay in installation and commissioning may invite cancellation of license.
4. Bidders are required to furnish clause by clause compliance of specifications bringing out clearly the deviations from specification, if any. The Bidders are advised to submit the compliance statement along with Technical Bid.
5. This is subject to the jurisdiction of Vijayawada/Guntur, Andhra Pradesh.

### **PART-III : STANDARD CONDITION OF EOI**

The Bidder is required to give confirmation of their acceptance of the Standard Conditions of the Expression of Interest mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder i.e. (Telecom Infrastructure Provider/IP in the Contract) as selected by The Licensor. Failure to do so may result in rejection of the Bid submitted by the Bidder.

1. **Law:** -The Contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.
2. **Effective Date of the Contract:** Normally the contract shall come into effect on the date of signatures of both the parties on the contract except when some other effective date is mutually agreed to and specifically indicated /provided in the contract. The deliveries and supplies and performance of the services shall commence from the effective date of the contract.
3. **Arbitration:** All disputes or differences arising out of or in connection with the Contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the Contract or relating to construction or performance, which cannot be settled amicably, may be resolved through arbitration at court at Vijayawada/Guntur.
4. **Non-disclosure of Contract documents:** Except with the written consent of the Licensor other parties shall not disclose the contract or any provision.
5. **Liquidated Damages:** In the event of the IP/Telecom Infrastructure Provider's failure to provide services as specified in this contract, the Licensor may, at his discretion, liquidate Bank guarantee up to 100%.
6. **Termination of Contract:** The Licensor shall have the right to terminate this Contract in part or in full in any of the following cases.
  - a. The installation/ placement of the tower is delayed for causes not attributable to Force Majeure for more than 02 weeks after the scheduled date of installation.
  - b. The Telecom Infrastructure Provider is declared bankrupt or becomes insolvent.
  - c. As per decision of the Arbitration Tribunal.
7. **Notices:** Any notice required or permitted by the contract shall be written in the English language and may be delivered personally or registered pre-paid mail/airmail, addressed to the last known address of the party to whom it is sent.
8. **Amendments:** No provision of present Contract shall be changed or modified in any way (including this provision) either in whole or in part except by an Instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.
9. **Taxes and Duties:** All types taxes & duty if applicable to be paid by IP in respect of this contract.



## **PART-IV : SPECIAL CONDITION OF EOI**

The Bidder is required to give confirmation of their acceptance of Special Conditions of the EOI mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder (i.e., Service Provider in the contract) as selected by the Licensor, Failure to do so may result in rejection of Bid submitted by the Bidder.

1. **Security Deposit:** After Award of Contract the successful bidder will have to pay a security deposit equivalent to six months of rental. This amount will be payable in favor of “Director, AIIMS Mangalagiri”. This amount will be refundable after completion of work and upon submission of NOC of the Superintending Engineer.
2. **Tolerance Clause.** To take care of any change in the requirement during the period starting from issue of EOI till placement of the contract, Licensor reserves the right to change the number of sites.
3. **Payment of License Fee:**
  - a) The License fees for the Premises shall be payable every quarter by 10th working day.
  - b) Rent will be increased @3% after expiry of each year on the last paid rent.
4. **Duration of License.** Initially the License will be issued to telecom infrastructure provider (IP) for a period of 5 years which will be further extended up to next 5 years on sole discretion of the Licensor. The duration of License will be counted from the date of operation of towers. The Telecom Infrastructure Provider will intimate the date of operation of tower in writing to the concerned AIIMS Mangalagiri Authority immediately on operation of towers.
5. **Issue of License:** The license/ MoU will be placed by the Licensor to the respective Telecom Infrastructure Provider/IP who will quote the total highest leased amount as per format given in Part VI of EOI.

## **PART-V : EVALUATION CRITERIA**

1. The broad guidelines for evaluation of Bids will be as follows:
  - a) Only those Bids will be evaluated which are found to be fulfilling all the eligibility and qualifying requirements of the EOI, both technically and commercially.
  - b) In respect of the Two-Bid system, the technical Bids forwarded by the Bidders will be evaluated by the Licensor with reference to the technical characteristics of the equipment as mentioned in the EOI. The compliance of Technical Bids would be determined on the basis of the parameters specified in the EOI. The Price Bids of only those Bidders will be opened whose Technical Bids would clear the technical evaluation.
  - c) The Highest Bid (H1) will be decided upon the highest leased rate quoted by the particular bidder as per the Price Format given in Part-VI.
2. **Price Bid Format:** The Price Bid Format is mentioned in Part VI. The Bidders are required to fill this up correctly and submit the same along with Price Bid.
