I. APPLICATION PROCESS:

- The duly filled and signed original application form must be produced at the time of interview along with One (1) set of Self Attested photocopies of Degrees, Certificates, Mark sheets, Age proof, Caste certificates, PwD certificate (in case applicable) etc. The same MUST be produced in original for document verification at the time of interview.
- **II.** The reservation for EWS/OBC/SC/ST candidate is as per Central Govt. rules and 4 % for PwBD candidates (on horizontal basis).

a) For OBC Candidate:

Candidates must attach certificate valid for the posts under the Central Government of India

which mentions that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the crucial date.

b) Economically Weaker Section (EWS):

Persons who are not covered under the scheme of reservation for SC's, ST's and OBC's and whose family has gross annual income below ₹ 8 lakh (Rupees eight lakh only) are to be identified as EWS's for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application. Such candidates should have valid income certificate on the date of application in the prescribed format or on the letter head of the issuing authority to this effect before filling the application and submit the same at the time of document verification, failing which their candidature will be rejected.
