II. Specifications for Hand Held Bi-Directional Vascular Doppler

- 1. Real-time waveform on in Built LCD display
- 2. Storage up to 30 waveforms in the internal memory
- 3. Should be made by a reputed international manufacturer with EU (CE 0123) or ISO 9001 & 14001.
- 4. Should be able to measure: Blood velocity measurement cm/sec (systolic velocity, Diastolic velocity, systolic diastolic ratio, Maximum & Minimum Velocity, Pulsatility index, Resistance Parameter, and heart rate) and blood volume measurement ml/sec.
- 5. Power supply: DC 9V, 9V alkaline battery.
- 6. LCD Display: 128 x 64 dots, STN LCD (Waveform & numeric data)
- 7. Automatic shut off: No signal: 2 min/ Freeze: 5 min, others:15min.
- 8. External outputs: Headphone Connector: Speaker cut of USB Connector: for PC Connection.
- 9. Maximum speaker output: 300 mW or more.
- 10. Dimensions: approx. 78(W) x141 (L) x 27 (H) mm (Probe holder not included)
- 11. Mode settings: Memory (Store, read & clear), Direction, Scale (Time & Unit), volume flow, Language, etc.

III. Specifications for Hand Held Doppler (Vascular)

- 1. It should be non-display, hand-held Doppler with recharge with excellent sound quality.
- 2. It should come with attachment of 8MHz non-directional probes for vascular applications.
- 3. Superior sound quality from high-fidelity speaker.
- 4. Powered by 3 rechargeable batteries and should be provided with battery recharger.
- 5. Should have an extended battery life of up to 6 hours.
- 6. It should have interchangeable probe capability.
- 7. It should have a user replaceable cable.
- 8. It should comfortable fit in the hand with dimensions not exceeding (HxWxL): 140 x70 x 35 mm and weight not exceeding 320 gms.
- 9. Should have a warranty of atleast 2 years or more.

IV. Technical Bid Documents:-

All the documents mentioned below are mandatory and are to be placed in the Technical Bid Envelope .They should be duly signed and pages numbered.

- a) The firm should provide an undertaking for acceptance of Terms & Conditions of AIIMS Mangalagiri against the NIQ. It should be printed on the Letter Head of participating Bidder Company, duly signed and accompanied with Technical Bid Document as per Format given at Annexure-II.
- b) Copy of Certificates/Standards for confirming the Quality of Supplied product: The quoted Item/Items should have applicable quality mark such as *ISI/BIS/ISO* 9002 for Quality assurance in Production and its utmost safety compliance for use in patient care should be mentioned and the copy of such applicable certification must be enclosed with the Technical Bid.
- c) Purchase Order / RC Copy from INI such as AIIMS Delhi, PGI Chandigarh, JIPMER, SGPGIMS, RML, State Government and Prominent Private Organizations, for the rates reasonability for the earlier supplied items, in the last financial years, if any.
- **d) Delivery period:** Delivery period of the items shall be **15 days** from the issue of supply order. The period of delivery as communicated through purchase/supply order has to be strictly followed by the Supplier.
- e) **Penalty:** Penalty @ **0.50% per week** will levied for late delivery on supply order value of the item and will be deducted from the payment Bill. The maximum penalty will be **10 %** of total value against any of Purchase/Supply Order total value.
- **f) Warranty Period**: Should be clearly mentioned in the quotation as per the OEM or company Norms.

V. Financial Bid Documents:-

- **a) Price Basics:** Unit base price should be inclusive of GST and all applicable expenses up to F.O.R (Freight on road) at AIIMS Mangalagiri.
- **b) Price Validity:** The quoted prices should remain valid for a period of **180 days** from date opening of NIQ.
- c) **Price Quotation Format:** Price should be quoted in the "Financial Bid" **format given at Annexure-I strictly** by the vendor.
- VI. The outer envelope superscripted as "Supply of Hand Held Doppler" at AIIMS Mangalagiri in sealed condition for the supply of item/items detailed in the Schedule of Requirement. All quotations should be type written or written with indelible ink, duly signed, stamped and pages numbered. Over written and erased entries will not be considered and treated as deleted entries.
