

**Tender Notification for Cooperative Student Mess in AIIMS, Mangalagiri.**

The Director, AIIMS, Mangalagiri invites tenders from the vendors/ contractors/firms to supply the diet to the Hostel Students of AIIMS, Mangalagiri for the period of one year. The vendor shall abide by the following conditions :

**Terms & Conditions:**

- 1) The rates & Menu shall be decided as per mutual arrangements amongst the students, warden & the Vendor/contractor.
- 2) The Security Deposit ( Refundable) of Rs. 2.00 Lakh should be submitted in the form of irrevocable Bank Guarantee.
- 3) The diet is to be provided for 80 to 100 Students of AIIMS, Mangalagiri and to any other employee of AIIMS Mangalagiri.
- 4) The tender document must be accompanied by a copy of PAN, Certificate of firm/company registration, and GST registration.
- 5) The bidder must be able to provide the service within specified time period as prescribed in the Work Order, failing which the work order will be cancelled and award will be given to another qualified bidder with the negotiated terms & conditions as per Institutes norms.
- 6) All disputes shall be subject to Mangalagiri Jurisdiction only.
- 7) AIIMS Mangalagiri reserves the rights to accept/reject any bid in full or in part or accept any bid other than the lowest bid without assigning any reason thereof. Any bid containing incorrect and incomplete information shall be liable for rejection.
- 8) The Tenderer shall comply with all existing labour legislations and Acts, Provisions, such as Contract Labour Regulation Act, Workmen's Compensation Act, Minimum Wages Act, Payment of Wages Act, Provident Fund Act, ESI Act, etc. For any lapse or breach on the part of the Tenderer in respect of non-compliance of any labour legislation in force during the validity of the contract, the Tenderer would be fully responsible and would indemnify the Institute, in case the Institute is held liable for the lapse if any, in this regard.

**Contractor obligation:**

- 1) Electricity charges shall be paid by the contractor as per actual consumption on the prevailing rates of Andhra Pradesh Southern Power Distributors Company Limited (APSPDCL) or Rs.10-00 per unit for kitchen area and Rs. 1000/- per month is fixed for water charges.
- 2) Annual whitewashing of kitchen and ancillary area.
- 3) All equipment & utensils/ cutlery to be supplied, cleaned / serviced by the contractor.
- 4) To maintain Ground Floor, Terrace, Toilet area in the most hygienic condotion.
- 5) The service provider will be responsible for cleaning of the kitchen, the dining area, surrounding area, toilets, washbasins, dust bins including oil & grease pit and pipelines carrying kitchen waste etc., with the phenol / disinfectants for maintaining proper hygiene.
- 6) The service provider will also provide soap cake/liquid soap and paper towels, door mats, naphthalene balls, etc.

- 7) Healthy, groomed workers, uniformed, with necessary safety gears will be in the scope of the contractor. The administration will have a veto on the continuation of any worker, whose conduct has been found to be not appropriate.
- 8) Provision of Healthy, nutrition's food.
- 9) Ordinary repairs / maintenance e.g. Lights, exhaust fans etc., required for day to day repairs will be in the scope of vendor.
- 10) In case of complaints on quality and conduct, the vendor will be answerable to AIIMS, Administration, which may decide to levy appropriate penalty / terminate the contract.
- 11) Sufficient counters for every meal shall be made operational. The decision of Mess Committee in this regard shall be final.
- 12) The Tenderer shall comply with all existing labour legislations and Acts, Provisions, such as Contract Labour Regulation Act, Workmen's' Compensation Act, Minimum Wages Act, Payment of Wages Act, Provident Fund Act, ESI Act, etc. The AIIMS authority is no one consent about the issues.
