10. Selection Process: Duly constituted ‘Standing Selection Committee’ will conduct the selection process for all the posts.

11. Other Conditions:

- i. All India Institute of Medical Sciences, Mangalagiri is an Autonomous Body established under Act of Parliament.
- ii. Service under the Institute is governed by that Act and the Rules & Regulations framed thereunder.
- iii. All the posts carry usual allowances as admissible to Central Government Employees of similar status at AIIMS, Mangalagiri.
- iv. The appointment will be subject to review and probation of two years.
- v. Assessment Promotion: A faculty after rendering fixed years of service on a grade may be considered for assessment promotion subject to the Rules and Regulations applicable from time to time in the Central Government Institutions/AIIMS.
- vi. The appointee shall be on the whole-time appointment of the AIIMS Mangalagiri and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind.
- vii. Canvassing of any kind will lead to disqualification. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- viii. The candidate should not have been convicted by any Court of Law.

- ix. The selected candidate is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
