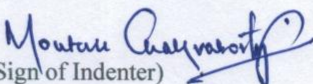

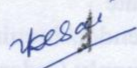
1. Similar items of other firms may not be specifically designed and validated for use with the existing laboratory analyzer (Victor 2D).

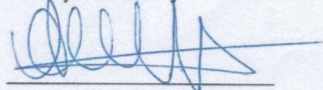

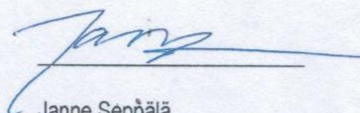
