The Terms of Reference of the Committee shall be as follows:

1. Study and examine the Guidelines issued by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice & Empowerment vide OM dated 08.11.2024 and other related instructions issued from time to time.
2. Review all sanctioned faculty and non-faculty posts of the Institute with reference to their functional requirements, duties and responsibilities.
3. Examine the indicative list of identified posts notified vide Notification No. 38-16/2020-DD-III dated 04.01.2021 and determine its applicability to the posts available in the Institute.

4. Identify additional posts, if any, not included in the notified indicative list but considered suitable for Persons with Benchmark Disabilities based on job requirements and functional considerations.
5. Recommend category-wise suitability of identified posts for various benchmark disabilities in accordance with the provisions of the RPwD Act, 2016 and the guidelines issued by the Government of India.
6. Submit a comprehensive report along with recommendations to the Competent Authority within 30 days from the date of issue of this Office Order.

The Committee may co-opt any subject expert(s) or seek information from Departments/Sections of the Institute, as required, for carrying out its mandate.
