1. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Mangalagiri reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India Rules / Circulars and requirements or otherwise.
2. *Reservation for Persons with Benchmark Disabilities (PwBDs) will be as per GoI guidelines.*
3. *Age will be counted as on the closing date of online application.*

4. *Relaxation of One-year Teaching / Research experience for SC / ST candidates will be given as per Rules / Guidelines issued by DoPT and Central Institute Body of AIIMS.*
5. *Reservation do not apply to posts filled on deputation basis.*
6. Overseas Citizen of India (OCI) cardholders under section 7(A) of Citizenship Act, 1955 are also eligible to apply for teaching post as per Ministry of Home Affairs Order No. 26011/52/2016- OCI dated 02nd August, 2018.
7. Teaching and/ or Research experience in recognized institutions in the subject of speciality will be counted for eligibility. Experience in Dental / Physiotherapy / Nursing College will not be considered for the eligibility.
8. *Experience will be counted as on 31st Dec 2026. However, the selection and appointment shall be subject to production and verification of documentary evidence establishing fulfillment of all eligibility conditions.*
9. Qualifications and experiences as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. The equivalent qualification will be decided by the Competent Authority of AIIMS, Mangalagiri and his / her decision in this regard will be final.
10. Period of experience wherever prescribed shall be counted after obtaining the prescribed educational qualification.

The aspiring applicants satisfying the eligibility criteria in all respects can submit their application only through ON-LINE mode followed by sending required documents via mail as outlined below. 3. Candidates must fill in the online application form as per the procedure given in the *Online application portal in the institute website* in due course of time and take a printout of the same.
4. Candidates must ensure that their hard copy of application & other relevant documents as mentioned below must reach the Institute within 10 days from the closing date of online application. The Experience Certificate should clearly show the duration of experience (“from” to “to”), Nature of experience (either teaching or research) etc. The candidates can only mention those teaching and/ or research experiences from recognized intuitions.
5. The *signed hard copies* of Online application along with all above-mentioned certificates / documents should be sent through Speed Post / Courier etc. within stipulated period, failing which candidature of the applicant will not be considered for the applied post.

11. **Selection Process:** Duly constituted 'Standing Selection Committee' will conduct the selection process for all the posts.
 - i. Interviews will be held at AIIMS Mangalagiri and mode as may be decided by the Executive Director, AIIMS Mangalagiri. Candidates called for interview will have to produce all relevant original documents for verification before the interview. They may also be asked to submit an affidavit / declaration regarding as decided by AIIMS Mangalagiri at the time of interview.
 - ii. After verification of documents, 'Standing Selection Committee' shall conduct interview/selection process for only eligible candidates against the post they have applied for. Candidates must note that mere appearing in interview does not confer them any right to selection. Candidates have to score minimum qualifying marks (suitability standard) in interview as given below for empanelment in the order of merit for selection. Candidates not scoring the minimum qualifying marks/suitability standard will not be considered for selection irrespective of their merit position.

12. Other Conditions:
 - i. All India Institute of Medical Sciences, Mangalagiri is an Autonomous Body established under Act of Parliament.
 - ii. Service under the Institute is governed by that Act and the Rules & Regulations framed thereunder.
 - iii. All the posts carry usual allowances as admissible to Central Government Employees of similar status at AIIMS, Mangalagiri.
 - iv. The appointment will be subject to review and probation of two years.
 - v. Assessment Promotion: A faculty after rendering fixed years of service on a grade may be considered for assessment promotion subject to the Rules and Regulations applicable from time to time in the Central Government Institutions/AIIMS.
 - vi. The appointee shall be on the whole-time appointment of the AIIMS Mangalagiri and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind.

- vii. Canvassing of any kind will lead to disqualification. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- viii. The candidate should not have been convicted by any Court of Law.
- ix. The selected candidate is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
- x. In case, any information or declaration given by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and/or any action taken as deemed fit by the appointing authority.
- xi. The decision of the competent authority regarding the selection of candidates will be final and no representation will be entertained in this regard.
- xii. Incomplete applications in any aspect will be summarily rejected.
- xiii. AIIMS Mangalagiri reserves the right of any amendment, cancellation, and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- xiv. AIIMS Mangalagiri reserves the right to increase or decrease the number of vacancies.
- xv. All disputes will be subject to jurisdiction of Court of Law at Vijayawada, Andhra Pradesh.
- xvi. Appointment of selected candidates is subject to his/her being declared medically fit by the competent Medical Board.
- xvii. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the Institute reserves the right to modify/withdraw/cancel any communication made to the candidate.

- xix. The persons belonging to SC/ST/OBC/ Persons with Benchmark Disabilities (PwBDs) must upload the certificate in the requisite proforma duly issued by the competent authority.
- xx. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non- creamy layer) in the prescribed format issued by Competent Authority. OBC candidate must ensure that they have a *valid OBC (non-creamy) layer certificate as on the cut-off date (issued on or after 01st April 2026)*. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).

Person with benchmark disability (PwBD) candidate(s) will be allowed in accordance with Ministry of Social Justice and Empowerment's, Notification No. 16- 15/2010-DD.III dated 29th July, 2013 as amended from time to time, in the above recruitment process. 2. Maximum age limit for applying for the post **other than professor is 56 years** and for the **post of Professor is 58 years** as on last date of receipt of application.
3. The initial period of deputation shall be 03 years further extendable as per DoPT regulations.
4. Applicants who fulfill the above qualifications/eligibility may submit the online application form as per the procedure given in General Conditions (Direct Recruitment).
